

Hammershøi, Krøyer og en Kongelig Samling

Gennem mine mange år som auktionarius har jeg haft et utal af værker under hammeren, der har sat sig spor i min bevidsthed. Når det er en særlig fornøjelse at præsentere et selvportræt af Vilhelm Hammershøi, skyldes det, at hans særegne gådefuldhed til stadighed fascinerer mig. Den er i høj grad til stede i det sublime selvportræt, som Hammershøi malede i 1911 under et ophold sammen med hustruen Ida i sommerboligen "Spurveskjul" i Frederiksberg. Velkendt er det stiliserede interiør, gråtoneskalaen og de utallige hvide nuancer, der gør vinduet i højre side af maleriet så utroligt levende og realistisk. Vi bliver mødt af kunstnerens alvorlige og intense blik, der vækker den karakteristiske undren og gør værket svært at afkode. Hammershøi har selv haft det hængende i sit hjem i Strandgade 25 på Christianshavn, og det har frem til i dag været i hans efterkommeres eje (kat.nr. 35).

En langt lysere stemning har P.S. Krøyer indfanget i værket "Spadseretur på Skagen Strand" fra 1909, der på forunderlig vis inkarnerer hans kunstneriske stræben. Skagens blå time og solnedgangens refleksion i havet er skildret på mesterlig vis, og værket skildrer tre kvinder i lyse lette sommerkjoler gående med hinanden under armen langs stranden – det er kunstnerens purunge datter Vibeke i selskab med familien Krøyers nære veninde Henny Brodersen og dennes datter, Lisbeth (kat.nr. 27). Værket er et studie til Krøyers sidste og ufuldendte store maleri, som vi også har haft fornøjelsen af at sælge på auktion for år tilbage.

Efterkommere til Frederik VIII har betroet os at sælge en større samling malerier og antikviteter med kongelig proveniens. Det gælder bl.a. et par store niarmede sølvkandelabre, der blev givet i bryllupsgave til Christian X og Dronning Alexandrine i 1898 (kat.nr. 183). Fra samlingen stammer også I.P. Möllers charmerende skildring af et sprudlende folkeliv foran Sorgenfri Slot fra 1810 – et værk, som regentparret fik foræret i anledning af deres 25-års regeringsjubilæum i 1937 (kat.nr. 7). I kataloget er alle effekter fra samlingen markeret med Frederik VIII's monogram.

Kunstobjekter fra Rusland og Fjernøsten har længe været eftertragtede på markedet, og denne gang præsenterer vi både en russisk og orientalsk auktion. Højdepunkterne tæller kunstneren Nikolai Petrovich Bogdanoff-Belskys motiv med en flok børn fra 1934, overdådige arbejder fra juveleren Fabergé i Skt. Petersborg og ikke mindst en tibetansk forgylt bronze-figur fra det 18.-19. århundrede, der forestiller den hellige lama Tsongkhapa på sin lotustrone. Den har været ejet af ingenør i Store Nordiske Telegrafsselskab, Carl Alfred Jensen, der var udstationeret i Kina fra 1911-1927 (kat.nr. 136, 162, 384).

Eksklusive smykker og armbåndsure har vanen tro også fundet vej til auktionen, heriblandt to italienske smykker med store diamanter – en Bulgari-broche og et par ørestikke fra omkring 1950 (kat.nr. 527, 535). Herrerne kan blandt andet se frem til et Rolex-ur model Cosmograph Daytona "Big Red" og et guldlommeur fra Vacheron Constantin (kat.nr. 693, 728).

Hammershøi, Krøyer and a royal collection

In my many years as an auctioneer, there have been countless works under the hammer which have left their mark on my consciousness. That it gives me particular pleasure to present a self-portrait by Wilhelm Hammershøi is because his characteristic mysteriousness never fails to fascinate me. It is very much present in the sublime self-portrait, which Hammershøi painted in 1911 during a stay with his wife Ida at "Spurveskjul", their summer house in Frederiksdal, with the familiar stylised interior, the greys and the countless shades of white that make the window on the right of the painting so vivid and realistic. We are greeted by the artist's serious and intense gaze, which awakens the characteristic curiosity and makes the work difficult to decipher. The painting used to hang at Hammershøi's own home at Strandgade 25 in Christianshavn, and has been in the ownership of his descendants until today (cat.no. 35).

A far lighter mood has been captured by P.S. Krøyer in his work "Spadseretur på Skagen Strand" (Walking on Skagen Beach) from 1909, which wonderfully embodies his artistic pursuits. Skagen's "blue hour" and the reflection of the sunset on the sea are masterfully depicted, and the work is populated by three women in light, gauzy summer dresses walking arm-in-arm along the beach – it is the artist's young daughter Vibeke in the company of the Krøyer family's close friend Henny Brodersen and her daughter Lisbeth (cat.no. 27). The work is a preliminary study for Krøyer's last and unfinished large painting, which we also had the pleasure of selling at auction some years ago.

Descendants of Frederik VIII have entrusted us with a large collection of paintings and antiques with royal provenance. The collection includes a pair of large, nine-armed silver candelabra given as a wedding present to Christian X and Queen Alexandrine in 1898 (cat.no. 183). The collection also features I.P. Møller's charming portrayal of a vibrant scene in front of Sorgenfri Palace from 1810 – a work given to the royal couple on the occasion of their silver jubilee in 1937 (cat.no. 7). In the catalogue all lots from the collection are marked with Frederik VIII's monogram.

Objets d'art from Russia and the Far East have been in demand on the market for some time now, and this time we present both a Russian auction and an Oriental auction. The highlights include the artist Nikolai Petrovich Bogdanoff-Belsky's scene depicting a group of children from 1934, lavish pieces by the jeweller Fabergé in St Petersburg and, not least, a Tibetan gilt bronze figure from the 18th-19th century, depicting the holy Lama Tsongkhapa on his lotus throne. It was once owned by Carl Alfred Jensen, engineer at the Great Northern Telegraph Company, who was stationed in China from 1911–1927 (cat.no. 136, 162, 384).

As you would expect, the auction also features exclusive jewellery and wristwatches, including two Italian pieces with large diamonds – a Bulgari brooch and a pair of ear pendants from around 1950 (cat.no. 527, 535). And for men, a Rolex watch model Cosmograph Daytona "Big Red" and a gold pocket watch from Vacheron Constantin (cat.no. 693, 728) are just two of the highlights to look forward to.

I hope you find something to tempt you!

Interior with Heinrich Albert Thalbitzer (1737-1785), Preussian consul in Helsingør. He is seated at a table in a pink dress and a lace shirt. On the table a candlestick and a letter addressed "To mr. Henry Thalbitzer Mercht (Merchant) to London". He is reading in a book with the title *The Guardian*. Inscribed on the old canvas: Gemahlt von R. von Gasc geb. von Lisiewsky Berlin 1762. Oil on canvas. 115 x 88 cm.

Heinrich Thalbitzer's and wife's white marble grave-stone comes with this lot. (2).

The painting is relined and the inscription is therefore hidden.

Anna Rosina Liszewska was born into a family of painters of Polish noble origin and was taught by her father. She later studied with the painter Antoine Pesne and learned his style of painting. His influence is obvious in the Thalbitzer portrait.

In 1741 Anna Rosina married the Preussian court painter David Matthieu (1697-1755). After his death she married Louis de Gasc in 1760.

J. M. Preisler was appointed court engraver in Copenhagen in 1745 and from 1754 professor at the Academy of Fine Arts.

The most famous engraving by his hand is the magnificent specimen of Saly's equestrian statue at Amalienborg, so large that he had to use two copperplates for the engraving.

According to information on the back of the painting, the motif has been used for the decorations in the dining room at "Valhøj".

The villa "Valhøj" was situated on a large site in Valby, Copenhagen, and was owned from 1821 by Joachim Dietrich Brandis. Lorenz Frølich who was a childhood friend of Brandis' son, Dietrich, was commissioned to decorate the villa's dining room. Frølich asked his fellow painters Lundbye and Læssøe to join him, and the three artists worked together on the job during 1839.

"Dansebakken" (the Dance Hill) was located at the corner of Kongevejen and Lottenborgvej opposite Sorgenfri Castle, where the hereditary prince Frederik had arranged a fête ground for ordinary people to enjoy outdoor life in the summertime.

The most famous painting depicting "Dansebakken" is by Jens Juel c. 1800 sold at Bruun Rasmussen auction 602, 1994 no. 22 to Statens Museum for Kunst (the National Gallery of Denmark) for 3.500.000 DKK.

Provenance: King Frederik VII's collection, the estate after the blessed King Frederik VII, auctioned at Christiansborg Castle 1864 no. 215. The collection of butcher Bech till 1937. Given as a jubilee present to Christian X and Queen Alexandrine in 1937 on the occasion of the royal couple's 25 years as King and Queen of Denmark. Hereafter, descendants of Frederik VIII (1843-1912) until today.

Enclosed: A letter to Christian X from Camilla Jenssen, dated May 13th 1937. In the letter Camilla Jenssen hopes that the King will receive the painting as a gift on the occasion of the King's 25 jubilee and she writes

the following about its history (in Danish): "Swedish officers were during the war in 1864 accommodated at the manor house Stensgaard on Funen at steward Trolle and his wife born Jenssen. After the war the Swedish officers sent this painting to express their gratitude. After the death of Mrs Trolle the family Jenssen inherited the painting and it has been in the family since."

The portrayed was earlier said to be Jens Juel's brother as mentioned above, but today there is no doubt that it is a portrait of mail contractor Jørgen Madsen Brøndsted.



Portraits of fellow painters was a popular motif in the Danish Golden Age. Wilhelm Bendz's portrait of Ditlev Blunck is one of the finest examples. It even possesses the further subtlety that the painter Ditlev Blunck in the painting is portrayed with his own sketch for a portrait of the painter Jørgen Sonne.

This study does not possess all the numerous details of the final portrait. However, there is a focus on the most important: The characteristic natural light from the window on the left side outside the painting, the reflection of the artist and the sketch in the mirror, and the overall composition. These three basic elements are all retained in the final portrait.

In 1823 the commission in charge of the decorations at Christiansborg ordered four scenes depicting Danish occupancies by C. A. Lorentzen, now at Amalienborg, catalogued in Weilbach as (in Danish): Patna at the Ganges, The roadstead at Christianssted on St. Croix, an Icelandic landscape and Søndermarken. Lorentzen made 4 sketches for these scenes. This painting is one of these sketches.

Patna was a Danish trade office/factory located at the Ganges River. The trade office was established in 1772, but it never became economically significant and was sold again in 1827.

Lorentzen has not tried to make a realistic depiction of the landscape at Patna. On the contrary, the painting represents the classical idea of an exotic ideal landscape with exotic animals (rhinos, camels), dancers, palm trees and classical buildings and ruins.

Edmund Bourke was born at Saint Croix, the former Danish West Indies, his parents were Irish. He had a long diplomatic career. He was a diplomatic representative in Warsaw from 1790, later on in Naples, Stockholm and Madrid. Bourke was appointed peace negotiator during the negotiations between Sweden and England later between Russia and England and Spain. In 1814 he was sent to London to work as a diplomat, and in 1820 he went to Paris.

Edmund Bourke had good friends in Denmark. The Schimmelmann family and the archaeologist and numismatist Georg Zoega among others. Jens Juel painted him twice and Bertel Thorvaldsen made a bust of Bourke in 1801.

Jens Juel was not only known as a painter of portraits. In his spare time and when he felt like it, Juel took up painting the landscape in its own right and not as background for a portrait.

He painted his first landscapes during his stay in Schwitzerland c. 1779. Here he was surrounded by nature lovers, natural scientists and not least the gorgeous and grandiose landscape, all that inspired him to paint the nature.

Back in Denmark the interest in landscape painting continued, and Juel began to paint the Danish landscape encouraged by different art collectors. A new

national feeling was arising, and the painters looked at the Danish landscape in a new perspective, inspired by the painters C. A. Lorentzen and Erik Pauelsen, who "discovered" the Norwegian landscape.

Jens Juel's landscapes are seldom dated and they are rather timeless. Ellen Poulsen has dated this landscape to the 1790ies? At that time he stayed out of town in the summer months to paint in the surroundings of Copenhagen.

Several of his landscapes have been identified for example from Fredensborg, Helsingør and also from Gamborg, Funen. They often possess a very classical and calm feeling. But Juel also painted more dramatic landscapes as a fire in the night, northern light or a gathering thunderstorm.


One of several portraits Vilhelm Hammershøi painted in the summer villa "Spurveskjul", which he rented in 1911. The house was originally designed and constructed by the painter N. A. Abildgaard. Hammershøi was so excited about the place, that he considered to buy the villa. In the summertime Hammershøi used to paint landscapes, but since he felt so comfortable in the villa, he worked indoors in the hall on the first floor under a barrel-vaulted ceiling and with a balcony with door and windows towards the garden. It was here he painted his self-portraits.

Knud Vad, "Hammershøi", 2003 pp. 351, describes the painting (in Danish): "Hammershøi has portrayed himself in the left part of the rectangular painting, turned towards the edge of the frame, the way he could see himself in the mirror, hence he seems to be lefthanded. In the right part he has painted the wall with the window and the door towards the balcony. The door is open into the room. This he would not have been able to see in the mirror, hence the painting is a composition. The grey/white walls and ceiling, the small window panes, the white door frame and the door with the brass knob lit up by the light from outside gives the whole painting an exquisite greyish tint.


In this bright and light room under the low vaulted ceiling his own body in the grey/black jacket has worked by its fullness and solidity. He must have felt this, and the painting is much more than just a self-portrait.... The composition gives the viewer an expressive and symbolic experience of the room".







CONDITIONS OF PURCHASE

§ 1. BIDDING

The buyer shall be the highest bidder at the "hammer price". Any person bidding on behalf of a third party shall be liable in surety for completion of the sale.

At the request of Bruun Rasmussen Kunstauktioner (hereinafter called Bruun Rasmussen), all bidders, whether they wish to make bids in person at the place of auction or commission bids by letter, fax or the homepage direct telephone bids or the homepage, should be able to document their ability to pay and be able to provide proof of identity at any time. Bruun Rasmussen is entitled to refuse to accept a bid if, when requested, adequate security or adequate payment on account has not been rendered.

Bids should be made by the bidder in person at the place of auction or by written commission by letter, fax or the homepage. For online auctions all bids are submitted via the homepage. Telephone bidding is possible within certain conditions made out by Bruun Rasmussen. Bruun Rasmussen is not to be held responsible for any errors that may occur using this service. The auctioneer shall have absolute discretion as to the increment of the bids. The auctioneer will also make decisions in all cases of doubt regarding the bidding.

Credit/debit card information must be registered with Bruun Rasmussen before bids can be submitted.

§ 2. PAYMENT

Purchases made at all Bruun Rasmussen online auctions are subject to a 25% fee, which covers 20% buyer's premium and VAT of the premium.

Purchases made at all Bruun Rasmussen traditional salesroom auctions are subject to a 30% fee (for wines, coins and stamps 25%), which covers 24% buyer's premium plus VAT of the premium.

Certain lots are sold in accordance with specific rules on normal VAT arrangement (hereinafter called normal VAT), so that the purchase price is the hammer price plus an additional 24% (for online auctions, wines, coins and stamps 20%) in buyer's premium and VAT of 25% levied on both the hammer price and the buyer's premium. Danish VAT registered buyers shall provide Bruun Rasmussen with documentation of their SE-/CVR -number (VAT No.) as this has to be quoted on the invoice for goods bought at full VAT.

For some foreign buyers, specific VAT-exemption rules apply (cf. Article 3). VAT-exemption does not apply to private buyers from the EU who are considered as Danish buyers (cf. current Danish legislation on Special VAT Scheme for Sales of Works of Art, Collectors items and Antiques by Public Auction).

The purchase price falls due for payment when the goods have been knocked down. Payment may be made in cash up to DKK 50,000, by Dankort, banker's cheque, traveller's cheque, Visa-, Master-, Diners Club- or Eurocard. Personal foreign cheques may only be used for payment by prior arrangement.

Payment may be made during or immediately after the auction. Under all circumstances payment must be made no later than eight days from the date of the invoice. With online auctions, payment takes place when the items are prepared for dispatch (circa 12 hours after the purchase has been made) using the banking details (credit/debit card and bank account) submitted by the purchaser. At the same time an invoice and dispatch information will be sent to the purchaser.

Should the purchase price not be paid by the due date, interest at 1.5 % per new month will be charged.

If the purchase price and interest are not paid within eight days after Bruun Rasmussen has sent its demand to the buyer, Bruun Rasmussen shall be entitled to rescind the sale and resell the goods at a Bruun Rasmussen auction or privately, and to demand reimbursement of any related losses from the defaulting buyer. Any further profit on the sale shall be payable to the person who had deposited the goods for sale by auction.

If the defaulting buyer is entitled to proceeds from a sale of goods by Bruun Rasmussen, Bruun Rasmussen shall be entitled to set off its receivables against its payables to the defaulting buyer.

If the defaulting buyer has deposited other goods for sale, Bruun Rasmussen shall be entitled to sell such goods at a Bruun Rasmussen auction without being bound by the reserve stipulated by the defaulting buyer. The defaulting buyer shall not be entitled to demand the surrender of goods deposited for sale as long as the debt payable to Bruun Rasmussen has not been discharged, regardless of whether the value of such goods may be deemed to exceed the debt payable.

Bruun Rasmussen shall be entitled to refuse a bid made by a buyer who is in default in respect to his payment obligations to Bruun Rasmussen, as well as a bid made by a third party on behalf of such a defaulting buyer. Bruun Rasmussen shall further be entitled to demand a deposit as a condition of accepting any future bids from such a purchaser.

§ 3. MONEY-BACK GUARANTEE

Online purchase of items by private individuals is subject to Danish consumer law, which extends 14 days of money-back guarantee. The purchaser is liable for any costs related to the transport of returned items.

Should a purchaser seek to avail himself or herself of the money-back guarantee, Bruun Rasmussen will refund the payment on receiving the returned items. Please note that the date on which accounts are debited is subject to the policy of the purchaser's bank/credit card company.

§ 4. EXEMPTION FROM VAT

International purchasers, who fulfill the conditions stipulated below, must pay a fee of 24% of the auction price at traditional salesroom auctions and a 20% fee of auction prices for items purchased online. They are exempt from the payment of Danish VAT.:.

A. Buyers residing in another EU Member State:

Buyers are exempt from paying Danish VAT as long as they have provided Bruun Rasmussen with documentation of their VAT registration. The VAT number will then be quoted on Bruun Rasmussen's invoice.

B. Buyers residing outside the EU:

- 1 Dispatch through forwarding agent: Lots exported through a forwarding agent approved by Bruun Rasmussen are exempt from VAT.
- 2 Export as personal luggage: Goods may be exempt from Danish VAT when the buyer personally takes the goods out of the country as luggage, provided the following conditions have been met:

The invoice must have been paid and the Danish duty of 25% of the invoice amount must have been deposited with Bruun Rasmussen.

- a Buyers residing in Norway will be refunded the Danish VAT as soon as the invoice of sale has been returned to Bruun Rasmussen endorsed by the customs authorities of the country in question or by any other authority with jurisdiction over matters of purchase tax with respect to official imports of goods into the country in question if the purchase price exceeds DKK 1,200.
- b Buyers residing in other countries outside the EU will be refunded the Danish VAT after the goods have been presented for customs clearance in connection with the departure of the buyer from the EU. The exporter's form should be returned to Bruun Rasmussen after being endorsed with the customs authorities' export certificate if the purchase price exceeds DKK 300. This also applies to the Faroe Islands and Greenland.

§ 5. PAYMENT OF TAXES AND DUTIES

- A. Buyers with VAT-registration in other EU member states who do not wish to make use of Article 3 may instead choose to purchase items subject to Special VAT/Normal VAT in the same manner as private buyers. Bruun Rasmussen must be notified of this before 10 a.m. on the following auction day.
- B. Buyers with VAT-registration in Denmark may choose to purchase subject to Normal VAT at 25% of the hammer price plus premium. Bruun Rasmussen must be notified of this before 10 a.m. on the following auction day.

§ 6. COLLECTION OF PURCHASES

The purchase price must be paid in full before the purchased lot can be passed over to the buyer. From the time of the lot being knocked down to the buyer, until its collection, the purchased lot will be held at the buyer's own expense and risk.

A storage fee will be charged for lots which have not been collected according to agreement. Lots which have been paid for but not collected will be stored at buyers expense. Lots not collected within 1 year will be resold at auction or privately at the buyer's expense.

§ 7. DISPATCH

Should Bruun Rasmussen undertake the packaging and forwarding of purchased goods, this shall be done at the buyer's own expense and risk. Bruun Rasmussen shall thus not be held liable neither for any damage caused to purchased goods during dispatch nor for any missing consignments.

§ 8. DROIT DE SUITE

In accordance with Danish copyright law, an additional royalty fee is to be paid for the purchase of works by contemporary Danish artist and some international artists who are either still alive or who have been dead for less than 70 years. The additional royalty fee will be collected by Bruun Rasmussen on behalf of Copydan, which is a Danish-based joint collecting society. Such works are marked with (CD) for Copydan next to the lot number.

The Copydan royalty fee is added to the auction price including the buyer's premium when the total exceeds €300.

Copydan royalty fees:

- 5% of the auction price and buyer's premium (excluding VAT) totalling up to €50,000.
- 3% of the auction price and buyer's premium (excluding VAT) of totals between €50,000 and €200,000.
- 1% of the auction price and buyer's premium (excluding VAT) of totals between €200,000 and €350,000.
- 0.5% of the auction price and buyer's premium (excluding VAT) of totals between €350,000 and €500,000.
- 0.25% of the auction price and buyer's premium (excluding VAT) of totals above €500,000.

Copydan royalties must not exceed €12,500 for an individual artwork.

The euro exchange rate has been set by Copydan for 2014 at DKK 745,89 per €100.

§ 9. EXPORT LICENCE

Applications for an export licence must be made to the Danish Cultural Assets Committee when required in accordance with current Danish legislation on the protection and preservation of cultural assets in Denmark. Where such a licence has not been obtained, the foreign buyer will be informed thereof immediately after the lot has been knocked down to the buyer. Another application will subsequently be sent to the Danish Cultural Assets Committee by Bruun Rasmussen on behalf of the buyer, now that the price is known. Should an export licence not be granted, the Danish Cultural Assets Committee would be obliged to acquire the purchased lot at the purchase price, and the buyer would thus not be bound to the purchase.

§ 10. DESCRIPTION OF LOTS

All lots are sold in the condition in which they are found when knocked down and as described in the catalogue and on the homepage with subsequently published changes and modifications. Description is done according to the best of Bruun Rasmussen's knowledge and on the cataloguing principles stated.

The lots auctioned are often of some age or of a kind which makes it possible that they may contain defects, deficiencies, or may have been subject to restoration or damage not necessarily stated in the catalogue and on the homepage. Pictures are for identification only and cannot be used for an evaluation of the condition of the goods.

Any person who wishes to bid at an auction should therefore satisfy himself of the condition of the lots for which he intends to bid by personal inspection at the preview held prior to the auction. The description is an indication of the prevailing opinion of scholars and expert at the time of the sale. If any doubts should

In the event of cancellation the buyer shall not be entitled to claim payment of interest on the purchase price nor shall the buyer be entitled to claim compensation for any other expenses or loss incurred, including any possible loss of profit in connection with reselling.

It shall not be possible to state cancellation of a purchase in pursuance of the above provisions if:

- a the description on the day the lot was knocked down to the buyer was in accordance with the then generally accepted opinion of scholars and experts;
- b the only way of establishing whether the lot was a forgery at the time of the sale was the implementation of scientific processes, the validity of which was only acknowledged after the time of the sale, or which would have required a disproportionate amount of cost, or which would have been impossible to carry out without damaging the lot in question.

In addition to the time-limits stated above, all purchases are subject to the Statute of Limitations stipulated by danish law by which Bruun Rasmussen is under no circumstance liable for purchases after 5 years from the date of purchase.

EXEMPTION FROM VAT

Buyers shall, according to § 2, pay full VAT on lots marked with an asterisk (*).

No Danish VAT is to be paid when VAT registered companies from other EU countries buy at Bruun Rasmussen and resell to private buyers. The private buyer then only has to pay VAT according to the rules in force in the country where the foreign company is VAT registered. For further information please consult your local authorities.


