NORTHERN LIGHT - the Artists' Colony at Skagen

"If you are a painter, follow us here. There are motifs for you. There is scenery worthy of poetry. Right here in Denmark, you will find a kind of nature that will make your mind drift to the desert of Africa, to the ashy hills of Pompeii and the bird-filled sandbars near the ocean."

Such were the words of the Danish fairy tale writer Hans Christian Andersen when he visited Skagen in 1854. In the decades prior to the turn of the century, it became increasingly common for poets, artists and other creative spirits to head for Denmark's northernmost point. Industrialisation, population growth, intensive construction and the outbreak of cholera in Copenhagen had changed the living conditions of those who lived there. It was not by chance that Skagen was the place where the famous artist colony was established, because it was there, in the small fishing village far from the capital, that the longing for the light, the air, the sea and a more authentic life in harmony with nature could be satisfied. From the windiest place in Denmark, the group of painters brought about a profound breakthrough in Danish art. Their works have been regular guests at our auctions at Bruun Rasmussen for many years and are sought after by collectors all over the world.

Now, for the second time, we are holding a Live Auction and subsequent Online Auction entitled "Northern Light – the Artists' Colony at Skagen" in collaboration with Bonhams' global network of auction houses. Here, we will provide a rich insight into the wonderful art created by the groundbreaking community of artists – painters who arrived in Skagen, bringing with them the most modern thinking and European currents. The plein-air studio unfolded in full bloom, and the motifs revolved around the sunlight, the beach, festive events in the artists' colony, the poor local people and the often-harsh life of the fishermen. The best-known names in the colony were the Danish painters P.S. Krøyer, Michael Ancher, Laurits Tuxen, Holger Drachmann, Anna Ancher, Viggo Johansen, Carl Locher, Marie Krøyer, the Norwegian Christian Krohg and the Swede Oscar Björck.

In this catalogue, you'll find the 71 works that will be sold at the Live Auction on Monday 10 June at 7 pm. A number of the highlights encapsulate everything that we associate with art from Skagen today, not least P.S. Krøyer's nude study of a boy at the water's edge from 1892. Here, the blue sea, the dazzling sunlight and the burgeoning vitalistic thinking play a decisive role, imbuing this small snapshot of life with a very special atmosphere. The local fishermen were another favourite motif, and with Krøyer, we meet three of them hauling a boat along the beach on a windless day, the sun casting long shadows on the sand. Michael Ancher has depicted the fishermen in somewhat harsher conditions – a group with hardened faces, putting on their life jackets, just before setting off on a perilous journey out to sea to secure their families' livelihoods. The auction offers a large number of other well-known motifs by the Skagen painters, and even more art works will go under the hammer at the subsequent Online Auction at bruun-rasmussen.dk on 17 June.






As early as 1882, the year after completing his education at the Academy of Fine Arts in Stockholm, Björck traveled to Skagen to join the artists' colony, which practised the new French plein air painting and everyday realism. He was a central artist among the Skagen painters and became an important communicator of the modern breakthrough in art in Sweden. In Skagen, he painted some of his most important pictures, e.g. "Et Nødskud" (An Emergency Shot) dated 1883 (National Gallery of Denmark Inv. No. KMS1236).

The painting was probably painted during Anna and Michael Ancher's stay in Paris on the occasion of the World Exhibition in 1889. Despite the important stay, there is almost nothing left that can tell us about the artist couple's time in the French capital. Elisabeth Fabritius writes about the present portrait in "Michael Ancher og det moderne gennembrud 1880–1890", 1999, p. 224 (in Danish): "There is something unusually awkward about Ancher's portraits from his stay in Paris, where the models sit as if waiting in front of him. This also applies to the full-length study of Anna Ancher in a festive dress, signed 1889 [...]. Perhaps a reflection of the uncertainty that befell Michael Ancher in the foreign metropolis, confronted with such rich art collections and such overwhelming visual art as the French." The painting is a study for "Fiskere paa Skagen Strand. Sildig Sommeraften" (Fishermen on Skagen Beach. Late Summer evening), which is located at The National Gallery of Denmark (Inv. No. KMS1233). Krøyer painted this in the summer of 1883. Here, a group of fishermen can be seen placed in the foreground, and Krøyer has worked with placing them in different positions – one standing, one sitting and three fishermen in different lying positions. The author Henrik Pontoppidan (1857–1943) visited Skagen in the summer of 1883 and followed the creation of the painting. Pontoppidan and several of Krøyer's artist colleagues devoutly admired Krøyer's struggle against time to capture the very specific "I'heure bleu" atmosphere.

Anna Ancher has also previously dealt with Death in her art. In the painting "Sorg" (Grief) from 1902, for instance, a young nude girl wrapped in her long hair kneels together with Ane Brøndum (Anna Ancher's mother) in prayer at a cross on the heath at dusk. The mood in this painting, as the title also suggests, is full of loss and grief. The present painting here is quite different. With its bright colours, it depicts our Lord as an All-father who with open arms embraces his small child. By the Lord's side are smiling and happy children who with flowers welcome their new friend/"playmate". DKK 60,000–80,000 / € 8,050–10,500

Here Mette Harbo Lehmann writes the following about the difference in the colour scheme between no. 383 in the Catalogue Raisonné and no. 382 (the present work) and points out how Krøyer has toned down the colours in the large painting (no. 383): "In a preliminary study for Krøyer's work, sold at an auction in 2012, it appears that he had toned downed his colour scheme during the painting process. The last fisherman who, in the study, falls somewhat behind the others, is wearing a darkblue shirt, the middle man a yellow raincoat, and the first an almost white sweater. In the finished work, Krøyer has brought them together and only emphasised the rhytm of their positions with alternating light- and dark brown colours. Moreover, the light green lyme grass aroung the light house in the background has become significantly less green."

In 1885 Bergens Kunstforening (today Bergen Kunsthal) commissioned a work by Krøyer, where he could decide the motif himself. In the autumn 1885 the final painting "Three fishermen dragging a boat" was sent to Bergen, and the reviewer of Bergens Posten was very enthusiastic and wrote about it on 7 November 1885 (in Danish):

"It depicts 'returning fishermen' dragging their boat along the beach in calm weather; the motif is from Skagen, whose lighthouse can be seen in the background to the left. There are three strong fishermen, especially the front one, who with the rope over one shoulder wades forward through the wet sand; the sun shines right in their faces, so that they laugh against the strong light. A little way out on the flat beach, the green boat glides forward, steered by a young man in the stern, and all the way to the distant horizon limited by a row of white summer clouds, the deep blue sea stretches its surface with bright spots here and there and in long incomparable movements. It is a picture of sunshine in which the main emphasis is placed on the atmosphere of nature and colour and it is radiantly true and freshly rendered. Danish art has never been better and more beautifully represented in our Kunstforening than by this picture, and we believe that our audience will be highly interested in getting to know one of Denmark's most talented artists." ("Krøyer i Internationalt Lys", exhibition catalogue, The Hirschsprung Collection and Art Museums of Skagen, 2012, p. 230).

Peter Michael Hornung writes the following about "Three Fishermen dragging a boat" (in Danish):

"The following year, Krøyer again used the same effective diagonal and the same towering horizon, when he finished 'Three Fishermen dragging a boat' [...]. This time the artist has turned around and painted his motif with the sun burning on his back. But it is debatable whether the actual motif is the three fishermen trotting off on the beach with a boat in tow, since the most surprising thing is the three shadows that the fishermen cast in the sand. They form a motif in itself [...] Krøyer did come to Skagen because of what he had been told about the light in this part of Jutland. The legendary light of this sky came to play the main role in the paintings that Krøyer painted in Skagen, whether he stayed indoors or outdoors." (Peter Michael Hornung: "Peder Severin Krøyer", 2002, p. 185-186).

The same fine characteristic applies to the present painting.



The motif is also known from a photo from Krøyer's private photo album (photo ill. in "P.S. Krøyer's Photographs", exhibition catalogue, The Hirschsprung Collection 1990, p. 116). Like many other artists of the time, Peder Severin Krøyer took many photographs himself and used them, among other things, as help in connection with the preparation for many of his most famous works – including, among others, "Sommeraften ved Skagens strand. Kunstneren og hans hustru" (Summer evening at the beach at Skagen. The artist and his wife) from 1899 (The Hirschsprung Collection).

In both photo and drawing, the artists Agnes Slott-Møller (1862-1937) and Marie Krøyer (1867-1940) are seen in conversation sitting in Marie and Peder Severin Krøyer's living room in their home in Skagen. They sit in the characteristic slatted sofa, which was designed by Marie Krøyer, whose well known furniture consisting of a sofa, two chairs, a stool and a table decorated the living room. The women's pose is the same in the drawing and photo, but the cropping is slightly different. The drawing shows the two women in full figure, the photo shows only the upper body. Thus, in the drawing, there is also room for the table, designed by Marie. The women's clothing is modern and typical of the period, and both the drawing and photo show Agnes Slott-Møller's characteristic brooch with the motif of a swan.

Agnes and Marie were lifelong friends. They got to know each other in 1885, before each of them got married, and the very close and confidential friendship lasted until Agnes Slott-Møller's death in 1937. Large parts of their correspondence are known, e.g. from the publication "Agnes and Marie. Letters between Agnes Slott-Møller and Marie Krøyer 1885-1937", ed. Lise Svanholm, 1991.

The studies in the Catalogue Raisonné are almost all detailed studies of a couple of the boys or – as here – a single one of them. The painting is a small work of art in itself and contains virtually all the artistic qualities that one would expect from a Krøyer painting: It is a motif from Skagen with the sun and the sea, the light is breathtaking, almost blinding, his beautiful bluish colour scale is used and in total it is an eminent evocation of a moment, catching the boy's movements here and now in the glinting whirling water. The meeting between the two young people in the doorway dates from the period 1877-78 when Michael Ancher's production was limited. Ancher painted pictures of folk life like this, with a touch of the Golden Age and National Romanticism in the early years of his career. At the same time, he worked on large portraits, but also carried out more realistic studies that point towards the modern trends of the 1880s.

From the second half of the 1870s, several pictures of folk life are known, in which the Skagen youth is at the center, such as "En forlovelse ved aften i en fiskerhytte" (An engagement in the evening in a fisherman's cabin) from 1876 and "Fiskeren der skal ud paa Fangst, tager Afsked med sin Førstefødte" (The fisherman going out fishing says goodbye to his first-born) from 1878 (Elisabeth Fabritius, A Catalogue Raisonné of the Works of Michael Ancher no. 83 and no. 127). The latter was painted in the same year as the present painting and seems to pick up the thread from the understated courtship scene: here another young couple has reached a step further on the path of life, as the fisherman says goodbye to his young wife and child. Both the courtship and farewell scenes take place in doorways, which on a very concrete level have given Ancher the opportunity to work with exciting lighting effects, but which probably also have symbolic significance as thresholds for development and the future. Anna Ancher was a pioneer in Danish art and is considered to be the most modern of the Skagen painters. A recurring theme in Ancher's art is her fascination with light. She was concerned with depicting the flow of sunlight into the room, and she has been praised for her unique ability to capture the materiality of light through vibrating colours and brushstrokes. With her focus on colours, surfaces and light rather than narrative content, her work points towards modernism and abstract art. In the present painting, Ancher has depicted a quiet moment in the living room, where a grandmother takes care of her grand-children. Here, too, she has masterfully captured the light that flows in through the airy curtains in the window and creates a beautiful play of colour on the surface of the table. Throughout his life, Michael Ancher was preoccupied with the life and work of fishermen, which was depicted in realistic depictions of the population and the landscape in and around Skagen. As he got to know the hard everyday life of the local people, his motifs took a more realistic direction. On 13 July 1874 in the afternoon, a young man arrives in Skagen. He is tired after the long journey and asks for the inn. A little later, he is finally with merchant and innkeeper Brøndum's family, who have settled in the garden house after the old inn burned down. The young man's name is Michael Ancher, and in his book about the painter "Michael Ancher", 2000, Claus Jacobsen writes about the artist's impression of the place: "- At one end there was a shop and an inn for fishermen, at the other a taproom for other people and a small guest room where exactly 2 beds and a washstand could stand; best to dress in the bed. Besides, there were three other rooms, one with 2 and two with 1 bed. That was enough for the needs of those times. But the house and the garden were pleasant and the stay cost only two kroner a day." As is well known, the meeting with Brøndum's Bod (shop) and the local people of Skagen was to become a turning point for Ancher's artistic career. Privately, too, the meeting with the Brøndum family was fateful: The young daughter Anna and the painter immediately took a liking to each other and in 1878 they became engaged. Brøndum's Bod (shop) was thus to become a focal point in Ancher's life, and the painter also liked to depict life here as it unfolded in the small but atmospheric taproom.

The present painting is a study for the painting "Nannina. En napolitansk blomstersælgerske" (The Hirschsprung Collection).

Krøyer painted the present study during his long trip abroad in the years 1877–1882, when he visited the sculptor Pasquale Fosca (1852–1928) in Naples. Here, Krøyer had the opportunity to test his talent as a sculptor with Fosca as his teacher, the only instruction Krøyer ever received in this subject. The work on the study of the beautiful flower seller was part of a commission given by Heinrich Hirschsprung (1836–1908) before the departure. Krøyer was allowed to use both Fosca's studio and his pretty model, the 16-year-old Nannina, for the assignment. The finished painting, now at The Hirschsprung Collection, became immensely popular when it was exhibited at Charlottenborg in 1881.

There was great interest at the time for motifs with beautiful young girls from the southern part of Europe surrounded by brightly coloured flowers. Earlier, Krøyer had used the motif when he painted "Two Gypsy Women" in Granada, where the young girl sits with flowers in her lap in the process of tying a bouquet; and the Spanish woman "La Frescita", who looks at the artist with a flirtatious look with flowers in her hair and a floral shawl. Both dated 1878. We also find paintings with similar motifs by e.g. Vilhelm Rosenstand (1838-1915), Edvard Petersen (1841-1911) and Kristian Zahrtmann (1843-1917) from the same period.

She made her debut at The Royal Theatre in Copenhagen in 1883 as Johanne in J.C. Hostrup's "Eventyr på fodrejsen", (Adventures on a walking tour).

Quote from Danish biographical encyclopedia, published in the period 1979-1984 (in Danish): "Her harmonious beauty meant that the minimum possible demands were placed on her education and gave her a larger repertoire than was otherwise the fate of a beginner. She sang cleanly, was sweet and endearing like the young girls of the vaudeville whose empire costume suited her".

The present painting is one among several in which the ancient theatre in Taormina is included. As early as in February 1901, Marie and P.S. Krøyer went to Sicily, where they met Heinrich (1836-1910) and Pauline Hirschsprung (1845-1912). During their stay, Krøyer received word that he had been granted a Civil List pension of DKK 3,000 per year. Good news, because the Krøyer family spent a lot of money. Later that year, Marie and P.S. Krøyer went to Norway, where Krøyer executed his renowned portrait of author and playwright Bjørnstjerne Bjørnson (1832-1910). Marie went on a spa stay in Larvik. In Norway, Krøyer's 50th birthday was also celebrated with, among others, Holger Drachmann (1846-1908) and Agnes Slott-Møller (1862-1937).

In this painting by the 26-year-old Krøyer, we experience the virtuosity and fascination of the darktoned interior, which the following year, in 1879, was expressed in the main works "Kunstnerfrokost i Cernay-la-Ville" (Artists' lunch in Cernay-la-Ville, Art Museums of Skagen, Inv. No. 1096) and "Et Sardineri i Concarneau" (A sardine curing and packing factory in Concarneau, National Gallery of Denmark, Inv. No. KMS3108).

Luchon is a small town in the Pyrenees close to the Spanish border. In January 1878, Krøyer left his teacher Léon Bonnat (1833–1922) in Paris to travel to Madrid together with Frants Henningsen (1850–1908), Frans Schwartz (1850–1917) and Julius Lange (1838–1896). This painting was created along the way and was in Krøyer's possession for the rest of his life. It became the basis for a slightly larger painting with the same motif (H. Chr. Christensen no. 187), which later came to belong to merchant Salomon Hertz (1830–1904) and wife Galathea Hertz (1837–1929).

The present work is either a sketch for the final large painting "Christian IX og Dronning Louise med familie i havesalen på Fredensborg 1883", which Tuxen worked on in the years 1883 to 1886 and which measures 440 x 670 cm. This work hangs at Christiansborg Castle (Lise Svanholm, A Catalogue Raisonné of the Works of Laurits Tuxen, 1990, no. 275). Or it is a repetition of the sketch for the above mentioned final painting (The Museum of National History at Frederiksborg Castle, Inv. No. 6818, and Lise Svanholm, A Catalogue Raisonné of the Works of Laurits Tuxen, 1990, no. 242).

All the many years Tuxen worked on the large painting tells something about the difficult and protracted process it has been to create such a large figure composition with so many important people. For three years, he was constantly on the move between St. Petersburg, Gmunden, London and Copenhagen to make detailed studies of all the portrayed, and this is the painting by Tuxen from which most sketches, studies etc. are preserved.

Tuxen had very early in the process laid out the overall composition – as seen in the present work – after he had attended a Royal banquet at Fredensborg Palace where he had settled on the right setting and the correct placement of the many princes and their families.

Christian IX became known as the father-in-law of all of Europe, as three of his children, in addition to Crown Prince Frederik (later Frederik VIII), were placed on European thrones: Empress Dagmar (1847-1928) was married to Alexander III (1845-1894), Tsar of Russia; Princess Alexandra (1844-1925) was married to the Prince of Wales, the later Edward VII (1841-1910); and Prince William (1845-1913) was appointed King of Greece in 1863 under the name George I. It was very important that the mutual ranking between all these royal persons was strictly observed in the overall composition (see photo with overview of who is who).

"Christian IX og Dronning Louise med familie i havesalen på Fredensborg" was Tuxen's debut as a painter of princes, and it was going to be decisive for his further career as an artist.


As Tuxen himself puts it just after he received the assignment for the painting: "I have to think of what Bonnat once said when I expressed to him my doubts about which direction I should take - "aah, that will be decided by chance - when I had painted Thiers's portrait, I got so many orders that I couldn't handle them all." ("Laurits Tuxen. En malers arbejde gennem tredsindstyve aar fortalt af ham selv", 1928, p.104).

Leon Bonnat (1833-1922) was Tuxen's teacher in Paris and the above quotation testifies that, in the same way as Bonnat's portrait of President Adolph Thiers from 1877 (Louvre, Inv. No. 20374) became decisive for his future as a portrait painter, Tuxen's Fredensborg painting became crucial for his future artistic career. Later, other great princely compositions followed, e.g. "The Family of Queen Victoria in 1887" (The Royal Collection, London, Inv. No. RCIN 400500); "The Marriage of Nicholas II, Tsar of Russia, 26th November 1894" (The Royal Collection, London, Inv. No. RCIN 404465); "Tsar Nicholas IIs coronation in the Uspenski Cathedral in Moscow" (The Hermitage Museum, St. Petersburg); and "The Marriage of Princess Maud of Wales, 22 July 1896" (The Royal Collection, London, Inv. No. RCIN 404464).

Anna Ancher has painted the motif with the young woman plucking a swan in different versions. There is, for example, a version at Kunsten Museum of Modern Art Aalborg (Inv. No. NK 10). Heide Grape-Albers writes about this: "In front of a white wall, which gets its light from the left, sits a young girl. The majestic-looking swan occupies almost the entire diagonal of the painting. Its head is hanging with its beak down on the floor, and its left wing is held in the air so that the woman can better reach the soft down on the chest and belly. The right wing emphasises the curved diagonal in the painting. The girl seems to have just started plucking. The quill is almost intact, yet the large copper pot at her feet is almost full of feathers. [...] the choice of the swan as a motif is unusual, as the picking of geese, ducks and chickens is far more common. But the composition's emphasis on the young girl and the swan - which even in death seems magnificent - on her lap is included and alludes to something mythological, which the educated, bourgeois audience must have noticed. The association with Leda and the swan is obvious." (pp. 90-91).

Mette Houlberg Rung, "Forenkling", in "Anna Ancher", The National Gallery of Denmark, The Art Museums of Skagen & Lillehammer Kunstmuseum, 2020–21, ill. p. 88, mentioned p. 89. Here, Houlberg Rung describes three different versions of the girl with the swan: "The group contains at least one smaller pastel and two larger oil paintings. The works are centered around the same motif, but the colour combination and cropping are different and show how Anna Ancher have worked with a number of different solutions on the same painting. Each work has its own characteristics, among other things the girls are dressed in red, blue and green respectively, and it does not seem to be the same model used in all three works. [...] It also seems to be the colours that she has been preoccupied with in the oil painting of the green girl [the present painting]. Here, the colour palette is reduced, and the complementary colours red and green completely dominate the composition, while Ancher has not, in the same way as in the others, worked with monumentality and simplification, as the room is rendered more in perspective, and there are more details." (pp. 89–91).

Plucking poultry is a motif Anna Ancher has used several times, the first time was with "To gamle, der plukker måger" (An old couple plucking gulls) from 1882 (The Hirschsprung Collection). In the middle of the 1880s, Anna painted "Gamle Lene plukker en gås" (Old Lene plucking a goose) (Art Museums of Skagen Inv. No. 775). Serious and concentrated, Lene does her work just like the old couple. Around 1900, Anna painted "Young girl plucking a swan". See lot no. 162. Again in 1904 the motif is coming up, this time with a group of people from Skagen plucking Christmas

geese.

Anna Ancher must have known Max Liebermann's "Women plucking geese", 1871/72 at the Staatliche Museen zu Berlin. There are strong points of similarity between Max Liebermann's goose picker placed on the right side and the young Skagen woman also on the right side of Anna Ancher's painting (for this interesting point see: Heide Grape-Albers, "Die Malerei Anna Anchers Einbliche in das Alltägliche" p. 58 in "Malerin Anna Ancher in Skagen", exhibition catalogue, 1994).



In 1901, Tuxen together with his wife, Frederikke, acquired a house in Skagen to be able to live there during the summer, and here he began his career as a Skagen painter. At this time Skagen had become a fashionable bathing place, and in the summer people came in large numbers to relax and recreate. In the following years, Tuxen painted a number of vitalistic works from the beaches around Skagen with a focus on the naked female body. These works are a tribute to the healthy naked body that enjoys the sun, the air, the sea and the beach without any shame at all.

The Venus rising from the sea, also called Venus Anadyomene, is a recurring motif for Tuxen in these years, and they are a reference to Greco-Roman mythology and the many classical models in the art of sculpture and painting, such as Sandro Botticelli's (1445-1510) "Birth of Venus" from 1485. The female figure has the same classical contrapposto position and long flowing red hair, but where Botticelli's Venus chastely covers her breasts and sex, Tuxen's stands proudly in all her nudity without blush and with raised arms. 



The present painting is one of at least five studies for the painting mentioned as no. 486 in H. Chr. Christensen's Catalogue Raisonné of the works of P.S. Krøyer "En gruppe Fiskere på Skagens Nordstrand" (A Group of Fishermen on Skagen's Nordstrand) with the dimensions 124 × 226 cm from 1891. This monumental painting is one of the largest works in Krøyer's production and it helped secure his artistic breakthrough in Germany, when it was exhibited in Munich in 1892 at the International Exhibition. It was sold to the Bayerische Staatsgemäldesammlungen and subsequently exhibited at the Neue Pinakothek. The painting was sold off the collection in 1936, when the museum's management changed its strategy regarding the collection's content.

In letter 232 dated 16.8.1879 Anna's cousin Martha Møller writes to her about Dansk Kunsthandel's exhibition (in Danish): "Dearest Anna, it is also really enjoyable to see your painting up there; - it is much, much better in colour than the one with the woman counting the money".

In letter 234 dated 17.8.1879 Thora Lunddahl writes to Anna about Dansk Kunsthandel's exhibition (in Danish): "On the other hand, I am looking forward to the exhibition and hope that its painting section will be extended over time, which seems to me to be very short. I have read with pleasure about Ancher's painting, which I hope I will have the opportunity to see. It's true, I can greet you from Stine (who feeds chickens). Ms Kinch and I ventured one day into the premises in Hovedvagts or ny Østergade, whatever it's called, to take a look at it".

In a letter (no. 1614), dated 27.2. 1903 Michael writes to his wife Anna about completing the present painting for the exhibition at Charlottenborg (in Danish): "So far, I have got just the weather I kindly asked Our Lord for, namely a sondenstorm, so I can complete the rescue paintings. The large one in particular has undergone a remarkable change. Today I have to work with the hands in it, indeed I have to settle for Niels Møller as a model, but for the hands it can work. I have been standing at the beach these two days with the paintings nailed to the bathhouse. It rained in between and yesterday afternoon it was too much, but then I had also been working for 3 hours".

A few days later on 5.3. 1903 (letter 1621) Michael again writes to Anna about working with the painting. He has problems with the weather and arthritis in his arm, but still the work continues. "Yesterday was grey and windy and then I got beach and sea on both lifeboat pictures and really seeing how it was, it was a good push".

The old schack in the painting was inhabited by the poor married couple Stine and Per Bollerhus, who were often used as models for Anna Ancher, among others. At the present auction there are two paintings by Anna Ancher, which depict Stine Bollerhus, standing in her little schack (see cat. no. 176 and 177). The couple lived by bringing bread out to the people living in Skagen and were therefore called "the old wheat bread people". Later, the schack was taken over by Bonatzi, who was one of Skagen's old eccentrics. After Bonatzi's death in 1913, the house was burned as a bonfire midsummer eve.

'Le peintre du soleil' – the painter of the sun. This was the poetic and concise moniker given to Schønheyder Møller by the French author and art critic Leon Bazalgette in the preface to the artist's retrospective exhibition at the Palais de Beaux-Arts in Liege in 1908, three years after his untimely death in 1905. It is a very beautiful characterisation and is telling of Schønheyder Møller's efforts to reproduce the sun and its light as it appears on the retina of the eye in a multitude of flickering spots in red, purple, orange and yellow shades when viewed directly up against the sun against the background of a blue sky.

Shortly after his death, Schønheyder Møller's works attracted great interest abroad, e.g. at the above-mentioned exhibition in Liege, but also in Berlin, London, Budapest, Stockholm and as far away as Cape Town in South Africa, and therefore some of his works must today be found abroad.

Subsequently, Schønheyder Møller was almost forgotten until today, where we once again see a strong interest in the artist and his works. His works have thus been on display at the exhibition "Fremkaldelser. Vilhelm Hammershøi, Valdemar Schønheyder Møller og fotografiet" at the Hirschsprung Collection in 2021.

Not much is known about the artist. As the above exhibition illustrates, he was a very close friend of Vilhelm Hammershøi, and they were both greatly interested and fascinated by photography. They were both some of the first artists in Denmark to work consciously with photography, which among other things also explains Schønheyder Møller's great pictorial interest in light. - 4.2 Items up for auction can have a reserve price that has been agreed upon with the seller. The price is confidential and the item cannot be sold below this price.
- 4.3 The Live Auctions are presided over by one of the Danish Ministry of Justice's appointed auctioneers, ensuring that the auctions proceed correctly and lawfully.

5 BIDDING

- 5.1 The currency used while the auctions take place is Danish kroner. The approximate amount in euro/US dollars is shown on screens in the saleroom and also on request.
- 5.2 The auctioneer determines the size of the bid increment and the pace of the auction. Bid increments usually rise by 5% - 10% compared to the previous bid. Approximately 50-100 auction lots are sold per hour.
- 5.3 The hammer price refers both to the gavel used by the auctioneer that signifies the end of a bidding round on an item and to the price (bidding amount) that the item up for auction is sold for. See paragraph 7 regarding amounts added to the hammer price.
- 5.4 The buyer is the bidder that submits the highest bid, thereby obtaining the hammer price. At the moment the hammer price is determined, a binding purchase/sale agreement is entered into based on these conditions of purchase.
- 5.5 If bids are made on behalf of others, the bidder serves as surety for the transaction.
- 5.6 Items are purchased in their present state and condition, and regardless of the type of bidding the buyer has no right to cancel his purchase, neither under the Danish Consumer Contracts Act.
- 5.7 Bidders are required, in accordance with BRK's instructions, to identify themselves and document their ability to pay, for instance by registration of a valid debit/credit card, bank guarantee or a deposit.
- 5.8 BRK may refuse to accept a bid if a sufficient guarantee of the bidder's ability to pay is not provided, or if the bidder has previously defaulted on payment obligations on purchases from BRK.
- 5.9 The overseeing auctioneer will, in consultation with the auctioneer at the podium, decide what to do in matters of dispute concerning a bidding round.

6 TYPES OF BIDDING

- 6.1 Bidding options:
 - IN PERSON:

Registration and obtaining the bidding paddle take place at the entrance to the saleroom. When the bidder wishes to bid, it is signalled to the auctioneer on the podium by raising the bidding paddle in the air and clearly displaying its number.

COMMISSION BIDS:

The intended maximum bid can be submitted via bruunrasmussen.dk until the start of the auction or by e-mail, fax or phone, so that the bid is received no later than 24 hours prior to the start of the auction. A commission agent bids on behalf of the bidder within the limits of the stated maximum bid. The commission agent will always bid the lowest possible amount to achieve the hammer price.

TELEPHONE BID:

With certain items it is possible to have a BRK employee call the bidder over the phone. The employee will then bid on behalf of the bidder during the auction. The service can be booked via bruun-rasmussen.dk up until three hours before the auction is set to begin.

LIVE BIDDING:

It is possible to follow the auction live and bid on the auction lots via bruun-rasmussen.dk.

PRE-AUCTION:

Some Live Auctions are preceded by an online auction. The highest bids from the online auction then represent the starting bids at the following Live Auction.

AFTER THE AUCTION

7 AMOUNTS ADDED TO THE HAMMER PRICE

- 7.1 In addition to the hammer price, see paragraph 5.3, the buyer pays a buyer's premium for the individual items as well as the other amounts described below if the conditions for these are applicable. The total amount that the buyer pays to BRK is called the "purchase price".
- 7.1.1 Buyer's Premium: The hammer price always includes an additional fee to BRK. At the Live Auctions, the fee is 25,6% of the hammer price + VAT of the fee, 32% in total. For stamps and coins, the fee is 20% of the hammer price + VAT of the fee, a total of 25%.
- 7.1.2 "LIVE Bidding": BRK's "LIVE Bidding" software is free to use for bidders on bruun-rasmussen.dk.
- 7.1.3 Full VAT: Certain items are sold at auction in accordance with the current rules regarding full VAT. In such a situation, a VAT of 25% is imposed on both the hammer price and the buyer's premium. These items are marked in the catalogue and on bruun-rasmussen.dk with the symbol "*", or with the text: "This item is subject to full VAT".
- 7.1.4 Artist's Resale Right: In accordance with Danish copyright law, a royalty fee covering the Artist's Resale Right has to be charged for works by newer Danish artists, and some foreign artists, who are either alive or have not been dead for more than 70 years. The royalty fee covering the Artist's Resale Right is charged on behalf of VISDA (Visual Rights Denmark). These works are marked "ARR" in the printed catalogue, and on bruun-rasmussen.dk the description of the works includes the text: "This lot is subject to the Artist's Resale Right". The royalty fee covering the Artist's Resale Right is added to the hammer price + the buyer's premium (excluding VAT) if the amount exceeds EUR 300, as indicated below:

Hammer price + buyer's premium (ex. VAT) Payment Rate

300,01 - 50,000 euro	5%
50,000,01 - 200,000 euro	3%
200,000,01 - 350,000 euro	1%
350,000,01 - 500,000 euro	0.5%
over 500.000 euro	0.25%

The royalty fee covering the Artist's Resale Right cannot exceed EUR 12,500 (excluding VAT) for each item. The fee must be paid in Danish kroner, and the conversion rate (EUR/DKK) is set by VISDA.

7.1.5 Debit/Credit Card Fee: Amounts Added to the Hammer Price: BRK reserves the right to charge the debit/credit card fees imposed by the payment services companies. The rates will appear when bidding on bruun-rasmussen.dk and at payment.

8 PAYMENT DEADLINE

8.1 The purchase price falls due after the hammer price has been determined, and then the buyer has eight days to pay BRK the purchase price.

9 PAYMENT METHODS

- 9.1 The payment can be made in the following ways:
 - A: With debit/credit card (Visa, MasterCard, Maestro, Diners Club, China UnionPay and JCB) or cash (up to DKK 14.999) in the saleroom or subsequently at one of

BRK's locations. Please note that we do not accept EUR 500 banknotes.

- B: With debit/credit card (Dankort, Visa, MasterCard, Diners Club and JCB) via BRK's website on the buyer's personal page.
- C: By bank transfer into BRK's account with Danske Bank: 4183 4310970638 · Swift/BIC: DABADKKK · IBAN: DK4130004310970638.

10 VAT EXEMPTION, PAYMENT & DEPOSIT

- 10.1 Some buyers can choose which type of VAT should apply to the transaction. The choice has to be communicated to BRK no later than two working days after the purchase and cannot be changed subsequently.
 - A: Businesses in Denmark registered for VAT can decide that the transaction is to be conducted in accordance with the rules for full VAT, see paragraph 7.1.3.
 - B: Businesses registered for VAT in another EU Member State can be exempted from paying Danish VAT if it can be proved that the item has been transported to the foreign address that the buyer has registered with BRK and which is written on the invoice. In such cases, the VAT should be settled according to the rules applicable in the country where the buyer is registered for VAT. It is advisable to consult with the local authorities. The buyer can decide not to be exempt from regular VAT and instead pay Danish VAT on second-hand goods/ full VAT.
 - C: Buyers residing outside the EU can be exempted from Danish VAT if it can be proved that the item has been transported out of the EU. To the extent possible and for a fee, BRK can issue the necessary export documents for the customs authorities. The buyer may decide not to be exempt from regular VAT and instead pay Danish VAT on second-hand goods/full VAT.
- 10.2 Companies registered for VAT in another EU Member State and buyers residing outside the EU must deposit the Danish VAT on the amount invoiced with BRK until the export process has been completed in a documented, lawful fashion. If the export is undertaken by one of BRK's authorized forwarding agents, the VAT does not have to be deposited. See the list of authorized forwarding agents on bruun-rasmussen.dk.

11 OVERDUE PAYMENTS

- 11.1 If payment is made after a deadline, including the deadline specified in paragraph 8, interest on overdue payments will be charged and estimated in accordance with the Danish Central Bank's official lending rate + 8% per year on the amount due.
- 11.2 If the purchase price, including interest, has still not been paid ten days after the demand for payment has been made, BRK is entitled to seek the purchase price paid by making a set-off against the deposit/by drawing on the bank guarantee or to cancel the purchase.
- 11.3 If the purchase is cancelled, BRK is entitled to sell the item at a new auction and demand the costs and any difference between the new and the earlier hammer price (including the buyer's premium) covered by the defaulting buyer.
- 11.4 In addition to debt collection, BRK may seek recovery of all due claims (including costs) not paid in a timely manner in the following ways:
 - A: Making the buyer cover the costs of selling items consigned to auction by or on behalf of the buyer. The sale can be conducted without regard to an agreed reserve price. Items consigned for auction cannot be collected as long as overdue debts are unpaid.
 - B: Seizing the buyer's remaining balance with BRK, including the balance from the sale of items consigned by or on behalf of the buyer, regardless of whether such receivables derive from auction sales prior to or after the date of the buyer's default on the payment.

12 PICK-UP & COLLECTION

- 12.1 The title to a purchased item passes to the buyer when the full purchase price, including any interest and fees, has been paid, and only then can the collection of an item take place.
- 12.2 In connection with the collection of a purchased item, BRK reserves the right to demand satisfactory documentation that the person who wants to pick up the item is either the buyer himself/herself or authorized by the buyer to receive the item on his/her behalf.
- 12.3 The collection of certain weapons requires presentation of a valid weapons certificate. Items with such requirements are listed with the text: "The purchase of this item requires the presentation of a valid weapons certificate" in the catalogue and on bruun-rasmussen.dk.
- 12.4 Purchased items are stored after the auction at the buyer's expense and risk. Pick-up must take place no later than eight working days after the last auction day.
- 12.5 If the item(s) is/are not picked up on time, the purchased items will be transported to a warehouse at the buyer's risk and expense. The transport costs are DKK 150 including VAT per item and the storage costs are DKK 150 including VAT per item for each week or part of a week. If an item is left unclaimed for an amount of time that results in the storage costs exceeding the value of the item, BRK will be entitled to, at the buyer's expense and risk and without regard to the reserve price, sell the item at an auction or privately. The buyer is still liable for the costs of transportation and storage not covered by such sale.
- 12.6 In accordance with current anti-money laundering laws, the buyer must in certain cases submit personal information and present a photo ID to BRK before the buyer can have the purchased item placed in his possession.

13 SHIPPING

13.1 If the buyer is unable to pick up the purchased item, BRK offers to pack and arrange delivery either by mail or by freight forwarder at the buyer's risk and expense. See paragraph 12.2 regarding identification.

14 EXPORT LICENSE

- 14.1 To ensure that Danish cultural heritage of vital importance remains in Denmark, the Danish Cultural Assets Commission can place an export ban on certain items. If the buyer wishes to export an item that is subject to an export ban in Denmark, the purchase will be cancelled and the Danish Cultural Assets Commission is obliged to acquire ownership of the item for the price obtained at auction. The buyer cannot raise any claims against BRK as a result of an export ban.
- 14.2 Certain items are included in the Washington Convention, also known as CITES. The purpose of CITES is to stop the trade of items made with endangered species and flora. If the item is included in the Washington Convention, CITES, Appendix 1, this will appear in the description of the item on bruun-rasmussen.dk and be marked with the symbol "[®]" in the catalogue. The following rules are applicable:
 - A: Items that are included in the Washington Convention, CITES, Appendix 1, can only be traded when a dispensation in the form of a CITES certificate has been obtained. BRK obtains the required certificate from the Danish Nature Agency that allows trade and export to countries within the EU. Items that were produced before 1947 can, however, be freely traded within the EU without a certificate.
 - B: It is only items included in the Washington Convention, CITES, Appendix 1 that are marked individually on bruun-rasmussen.dk and in our catalogue. Items included in the Washington Convention, CITES, Appendix 2, which can be freely sold and transported within the EU, are not individually marked.
 - C: Export to countries outside the EU must, regardless of the year of the item's production, always procure a CITES re-export permit from the Danish Nature Agency if the item is included in the Washington Convention, Appendix 1 and 2. This export permit can usually be

obtained without problems, if the item is either sold with a CITES certificate or was made prior to 1947. Appendix 2 items usually also receive a re-export permit without problems. Any fees charged by the Danish authorities in connection with the issuance of a reexport permit will be added to the buyer's invoice.

D: In connection with export to other countries outside the EU, special rules may apply concerning the subsequent import, and the buyer is encouraged to consult the relevant local authorities about this issue.

15 DEFECTS IN THE PURCHASED ITEMS

- 15.1 The lack of conformity rules of the Danish Sale of Goods Act may apply. Below is a non-exhaustive excerpt of the buyer's remedies in regard to lack of conformity.
- 15.2 The buyer is entitled to cancel a purchase if the description contained significant errors that have led to a higher hammer price than a correct description would have resulted in. In such cases, the total purchase price will be refunded. The buyer cannot demand payment of interest on the purchase price or demand payment of any other expenses or losses.
- 15.3 A purchase cannot be cancelled and the buyer cannot demand a refund of the purchase price or raise any other claims against BRK if the description of the item is in compliance with paragraph 2. The same applies if evidence of forgery has required the use of scientific methods that were either not available at the time of sale, were excessively costly to use or led to the damage of the item in question.
- 15.4 Claims for a cancellation of a purchase must be notified to BRK when the buyer has discovered the fact that entitles the buyer to cancel the purchase. This notice, however, has to be given no later than two years after the final pick-up date according to paragraph 12.4. The item purchased must be returned to BRK in the same condition as it was on the day it was sold at auction. If these conditions are not met, the buyer loses the right to cancel the purchase and cannot claim a refund of the purchase price. The buyer is responsible for paying the costs associated with the return of the item.

16 OBJECTIONS & LIMITATIONS OF LIABILITY

- 16.1 BRK is aware that errors, technical difficulties and external abuse or disruptive influences may occur during the auction. Bidders cannot raise any claims against BRK as a result of such events.
- 16.2 The buyer is always responsible for the correct payment of VAT and other costs, fees etc. in accordance with Danish and foreign regulations.
- 16.3 Unless otherwise stated in these conditions of purchase, BRK may never be held liable for bidders'/buyers' operating loss, loss of profits, other indirect losses or consequential loss.

17 PRIVACY POLICY

17.1 It is important to BRK to ensure confidentiality and security regarding the bidder's/buyer's personal information. The privacy policy can be found on bruun-rasmussen.dk.

18 COMPLAINTS, DISPUTE RESOLUTION AND APPLICABLE LAW

- 18.1 BRK can always be contacted if the bidder/buyer has a complaint.
- 18.2 If the dispute cannot be resolved, the consumer can submit a complaint to the Complaint Resolution Centre, Nævnenes Hus, Toldboden 2, 8800 Viborg, Denmark, email: naevneneshus.dk. Consumers residing in another EU country than Denmark can submit their complaint to the European Commission's Online Dispute Resolution platform via the website: http://ec.europa.eu/odr.
- 18.3 In Denmark, disputes must be brought before the City Court of Copenhagen, but see paragraphs 18.2. The mandatory rules on jurisdiction apply to consumer interests.
